Skipping Club, Team or Group  A club, team or group providing skipping-related programs, activities, services or events.	<ul> <li>Must be endorsed as a skipping club, team or group by Skipping Australia.</li> <li>Where one exists, must be an affiliate of the relevant State/Territory Peak Sporting Body for skipping.</li> </ul>	<ul> <li>Promoted by Skipping Australia as a skipping club, team or group.</li> <li>Insurance cover for the club, team or group's activities (including for athletes, staff, volunteers and spectators).</li> <li>Eligible to register athletes for events hosted by Skipping Australia.</li> <li>Invited to IJRU member-only educational webinars (via Skipping Australia).</li> </ul>

Corporate Partner	A for-profit organisation providing skipping-related goods, programs, activities, services or events.	<ul> <li>Corporate partnership status will be reviewed annually by Skipping Australia.</li> <li>Not eligible to use Skipping Australia's insurance cover for activities.</li> <li>Not eligible to vote.</li> </ul>	<ul> <li>Can promote affiliation with Skipping Australia.</li> <li>Recognised by Skipping Australia as a corporate partner.</li> </ul>
Sponsor / Benefactor	An organisation providing significant financial or in-kind support to Skipping Australia's activities.	<ul> <li>Sponsor/benefactor status will be reviewed annually by Skipping Australia.</li> <li>Not eligible to vote.</li> </ul>	<ul> <li>Recognised by Skipping Australia as a sponsor or benefactor.</li> <li>Can promote affiliation with Skipping Australia.</li> </ul>

This category includes participants training to participate in competitive skipping activities, such as a state or national competition.	<ul> <li>Insurance cover while training, competing or traveling to and from programs, services or events offered by Skipping Australia and their affiliates.</li> <li>Eligible to register for all competitions (subject to other eligibility criteria).</li> <li>Eligible to vote (if over 18 years) or have a parent / guardian / family member with voting privileges.</li> <li>Eligible to hold State/Territory and Australian records (subject to other eligibility criteria).</li> <li>Eligible to nominate for Skipping Australia Committee and/or subcommittee (if age and other selection criteria met).</li> <li>Eligible to represent Australia at IJRU Technical Committee/Technical Congress committee positions (subject to Skipping Australia's Executive's recommendation).</li> </ul>		
Recreation member	A person with access to a limited range of programs and services offered by Skipping Australian and their affiliates. This category includes participants undertaking non-competitive skipping activities, such as a recreation or fitness skipping class, or a short-term skipping program or event (eg a 'come and try' day)	<ul> <li>Insurance cover while training, competing or traveling to and from in programs, services or events offered by Skipping Australia and their affiliates.</li> <li>Eligible to register for local, regional and State/Territory competitions (subject to other eligibility criteria).</li> <li>Not eligible to register for National/International competitions.</li> <li>Eligible to vote (if over 18 years) or have a parent / guardian / family member with voting privileges.</li> <li>Eligible to hold State/Territory and Australian records (subject to other eligibility criteria).</li> <li>Eligible to nominate for Skipping Australia Committee and/or subcommittee (if age and other selection criteria met).</li> <li>Eligible to represent Australia at IJRU Technical Committee/Technical Congress committee positions (subject to Skipping Australia's Executive's recommendation).</li> </ul>

Official member	A person undertaking a coaching, judging or officiating role in programs, services or activities offered by Skipping Australia and their affiliates.	<ul> <li>Where available, official members must maintain relevant accreditations and certifications (eg IJRU judging certification).</li> <li>Insurance cover while working or traveling to and from activities offered by Skipping Australia and their affiliates.</li> <li>Eligible to vote (if over 18 years) or have a parent / guardian / family member with voting privileges.</li> <li>Eligible to nominate for Skipping Australia Committee and/or subcommittee (if age and other selection criteria met).</li> <li>Eligible to represent Australia at IJRU Technical Committee/Technical Congress committee positions (subject to Skipping Australia's Executive's recommendation).</li> </ul>		
Parent / guardian / family member	This applies to parents, guardians and family members of children under the age of 18 who are competitive or recreation members.  Please note: once a child turns 18, the parent / guardian / family member has the opportunity to join as an Individual Member.	<ul> <li>A maximum of four parent / guardian / family memberships will be available for each financial competitive athlete or recreation member, under the age of 18.</li> <li>Insurance cover while volunteering/working or traveling to and from activities offered by Skipping Australia and their affiliates.</li> <li>A maximum of one parent / guardian / family member per athlete member under the age of 18 is eligible to vote.</li> <li>Eligible to nominate for Skipping Australia Committee and/or subcommittee (if age and other selection criteria met).</li> <li>Eligible to represent Australia at IJRU Technical Committee/Technical Congress committee positions (subject to Skipping Australia's Executive's recommendation).</li> </ul>
